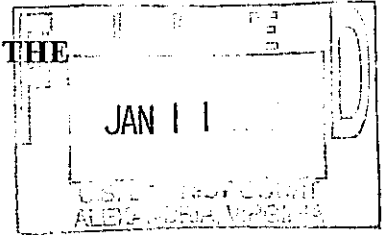

**JUDGMENT ORDER**




